

Domestic abuse rehousing advice

We believe that no one should live in fear of violence or abuse from a spouse, partner or ex spouse or partner. We recognise that domestic abuse can be experienced by men, women or children, of any age, in all social groups and from all ethnic backgrounds and sexual orientations.

We define abuse as an expressed fear which includes physical and verbal violence, harassment, threatening conduct or any conduct giving rise, or likely to give rise, to physical or mental injury, fear, alarm or distress from a person who is living, has lived with an applicant or a person with whom the applicant has an existing or former relationship.

How to get help

Contact us. We are happy to discuss your situation with you and give you advice. We take a flexible approach to responding to requests and take account of the varying circumstances of the applicant and the different courses of action which may be available . We take a victim led approach and will:

- offer an applicant an interview within one day of making a report to our office.
- offer advice on a possible course of action both to respond to the inmediate situation and to deal with the longer term.
- arrange an interview with the Local Community Casework Team.
- offer private interview facilities, wherever possible, with an Officer of the same gender.

- arrange for the services of an interpreter if required.
- accept an applicant's expressed fear and, although we will ask for supporting information, depending on the circumstances, we may not always insist on it.
- provide all applicants with a list of advice and information agencies.
- not disclose information to a third party without the explicit consent of the applicant, however we do reserve the right to disclose relevant information to statutory agencies where we consider that in so doing, it will contribute to the prevention of crime or where there are child protection related issues.
- accept referrals from other housing agencies who have a tenant who wishes to be rehoused in one of our areas.

Rehousing

Applicants who are assessed as victims of domestic abuse will be given Urgent or High Priority in line with our Allocation Policy. Applicants will normally be considered for rehousing on a "like for like" basis and away from the applicant's local area
