How will the Mears Pathways Programme work?

Access to Pathways for our customers and colleagues is straight forward and easy.

Customers

Pathways will support our social value work, creating chances for our customers to access learning. Access will be available in 2 channels:

1. Group Learning

There is a prime opportunity to work with your client teams, customer groups, community networks to participate.

2. Independent Learning

Individuals will complete with e-learning and online support from Learning Curve Group, via a work book.

- 2. After enrolment you will have immediate access to the Learning Curve Group e-Learning platform where you will be able to begin your course.
- 3. Meanwhile, Learning Curve Group will process your application for funding and a specialist tutor will be assigned to support you
- 4. Learners work their way through their online programme
- 5. Courses take 6 to 8 weeks to complete
- 6. Learner receives certificate about 3 months after completion of the programme
